

Preface

Welcome to the fifth edition of *Computers in the Medical Office*. This text/workbook introduces you to the concepts and skills you will need for a successful career in medical office billing. Medical biller is one of the 10 fastest-growing allied health occupations. This employment growth is the result of the increased medical needs of an aging population, advances in technology, and the growing number of health practitioners.

YOUR CAREER IN MEDICAL BILLING



Medical billing specialists play important roles in the financial well-being of every health care business. Billing for services in health care is more complicated than in other industries. Government and private payers vary in payment for the same services, and healthcare providers deliver services to beneficiaries of several insurance companies at any one time. Medical billers must be familiar with the rules and guidelines of each health care plan in order to submit the proper documentation so that the office receives maximum appropriate reimbursement for services provided. Without an effective billing staff, a medical office would have no cash flow!

Administrative duties in medical offices are becoming more dependent on technology. Computers are now used in almost all medical practices, for a variety of administrative and clinical functions. Anyone who seeks a job in medical billing will find that an understanding of the billing process and hands-on experience with billing software are often prerequisites to being hired. Although this text/workbook features Medisoft Advanced Version 11 Patient Accounting, its concepts are general enough to cover most administrative software intended for health care providers. Students who complete *Computers in the Medical Office* should be able to use other medical administrative software with a minimum of training.

In addition to specialized knowledge about medical billing and computer skills, you will also need to possess excellent customer service skills to succeed in this field. Even though they are not involved in the actual process of providing medical care, medical billers come in contact with clients, insurance companies, and patients. For example, incoming calls from patients who have questions regarding a charge are often directed to the billing staff, who must be able to communicate effectively with all types of people.

Medical billing is a challenging, interesting career, where you are compensated according to your level of skills and how effectively you put them to use. Those with the right combination of skills and abilities may have the opportunity to advance to management positions, such as patient account managers, physician office supervisors, and medical office managers. The more education the individual has, the more employment options and advancement opportunities are available. Individuals who have practical experience using computers and patient billing software will find themselves well prepared to enter this ever-changing field.

OVERVIEW

Computers in the Medical Office is divided into four parts.

Part 1, "Introduction to Computers in the Medical Office," covers the general flow of information in a medical office and the role that computers play. Instructors may wish to use the first part as a review or, if students

have had other courses in computers, they may wish to start directly with Part 2. A test has been provided in the Instructor's Manual to determine the level of students' familiarity with computers.

Part 2, "Medisoft Advanced Patient Accounting Training," teaches students how to start, input data, and use Medisoft to bill patients, file claims, record data, print reports, and schedule appointments. The sequence takes the student through Medisoft in a clear, concise manner. Each chapter includes a number of exercises that are to be done at the computer. These exercises give the student realistic experience using an administrative medical software program.

Part 3, "Applying Your Knowledge," completes the learning process by requiring the student to perform a series of tasks using Medisoft. Each task is an application of the knowledge required in the medical office.

Part 4, "Source Documents," gives the student the data needed to complete the exercises. These forms, including patient information forms and encounter forms, are similar to those used in medical offices.

COMPUTER SUPPLIES AND EQUIPMENT

The Student Data Template CD-ROM that comes with the text/workbook provides a base of case study information. Other equipment and supplies needed are as follows:

- ◆ CD-ROM 2X or faster disk drive
- ◆ External storage device for storing backup copies of the working database
- ◆ Mouse or compatible pointing device
- ◆ Windows 2000 or Windows XP operating system.

TO THE STUDENT

Computers in the Medical Office includes a tutorial and a simulation. Once you learn how to operate the Medisoft Advanced Version 11 program by completing the tutorial, you can practice those skills by working through the simulation. Both the tutorial and the simulation use a medical office setting, Family Care Center, to provide a realistic environment in which you can learn how to use the software.

Medisoft is a popular patient billing and accounting software program. It enables health care practices to maintain their billing data as well as to generate report information. The software handles all the basic tasks that a medical biller needs to effectively perform his/her job. As such, Medisoft is an excellent training tool for anyone interested in working as a medical biller. Even if you do not use Medisoft on the job, the skills you learn here will be similar to those skills needed to use almost any medical accounting program. You will learn how to perform the following tasks:

- ◆ Input patient information
- ◆ Enter patient transactions
- ◆ Create insurance claims
- ◆ Produce patient statements
- ◆ Enter payments and adjustments
- ◆ Produce reports
- ◆ Create collections letters



The prerequisite for successful completion of *Computers in the Medical Office* is an understanding of the concepts and procedures for medical coding, billing, and reimbursement. This background can be obtained by studying McGraw-Hill's related insurance titles, the briefer, focused *From Patient to Payment* (Newby) or the longer, comprehensive *Medical Insurance* (Valerius/Bayes/Newby/Seggern). Students must also possess basic computer skills, and familiarity with the Windows operating system.

After completing *Computers in the Medical Office*, students can build on their skills and enhance their qualifications for employment by studying *Case Studies for the Medical Office*, an excellent "internship in a box." *Capstone Billing Simulation* contains a simulation covering two weeks of work in a medical office using Medisoft. In addition to providing activities through which students can practice and reinforce their basic Medisoft skills, the text/workbook introduces new Medisoft training topics which expand their knowledge.

- ◆ **New organization of chapters** follows the steps in the medical billing process. The ten steps of the medical billing process are introduced in Chapter 1. Subsequent chapters follow the order of work tasks based on this billing process, creating a logical connection between chapters and the flow of on-the-job tasks.
- ◆ **Instructor's Manual** has Medisoft exercise solutions for each chapter. The Instructor Productivity CD-ROM (IPC) is included in the Instructor's Manual. The IPC contains chapter-by-chapter PowerPoint presentations and EZTest test generator. Questions from EZTest can easily be used with eInstruction's Classroom Performance System. The CD also includes Medisoft backup files for Chapters 4-15.

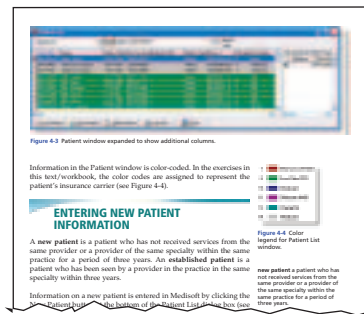

SHORT CUT The quickest way to open a patient or case is to double-click on the line associated with a patient or case.

At the top right side of the Patient List dialog box, there are two radio buttons: Patient and Case. When the Patient radio button is clicked, the left side of the window becomes active. Correspondingly, when the Case radio button is clicked, the right side of the window becomes active. The command buttons at the bottom of the dialog box vary depending on which side of the window is active. When the Patient window is active, the command buttons at the bottom of the screen include Edit Patient, New Patient, Delete Patient, Print Card, and Case.

The Patient window contains the following data: Chart Number, Name, Date of Birth, Social Security Number, Patient ID #2, Patient Type, Phase 1, Provider, Last Name, Billing Code, and Patient Indicator. There is not enough room in the Patient window to display all this information, so only a portion is visible at one time. The additional patient information can be viewed by using the scroll bar, maximizing the dialog box, or resizing the Patient area of the dialog box (see Figure 4-3).

EXERCISE 4-6

Practice searching for and editing information on Hiro Tanaka.

1. Open the Patient List dialog box. Confirm that the Field box entry is Last Name, First Name.
2. Search for Hiro Tanaka by keying the first few letters of her last name in the Search for box. Notice that as soon as the "T" is entered, all patients except Tanaka disappear from the Patient List window, because Tanaka is the only patient whose last name begins with "T".
3. Click the Edit Patient button.
4. Click the Other Information tab.
5. Click the triangle button in the Employer box. Click McCoy Manufacturing Inc. on the drop-down list. Notice that the program automatically enters the phone number in the Work Phone box.
6. Select Full Time from the Status drop-down list.
7. Click the Save button to store the information you have entered.
8. Close the Patient List dialog box.

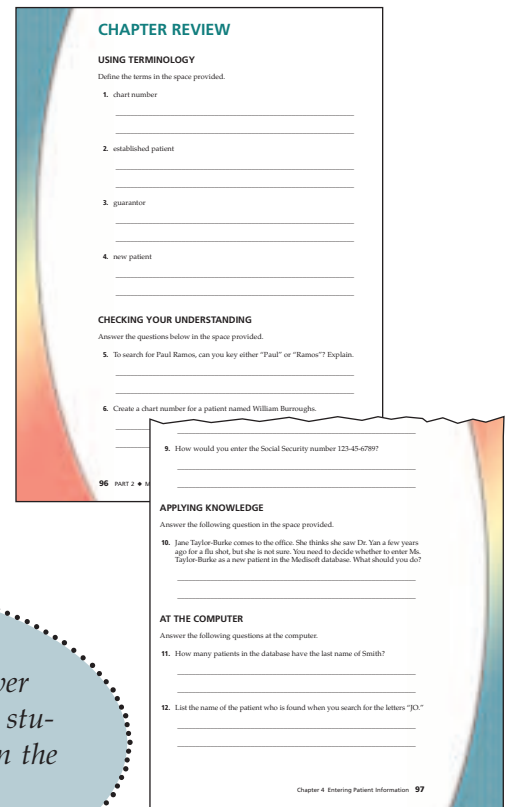

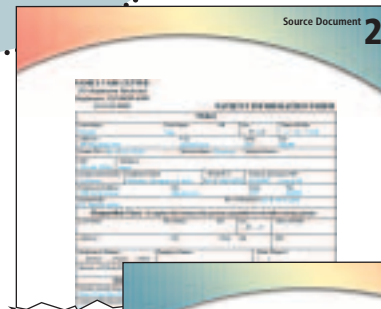

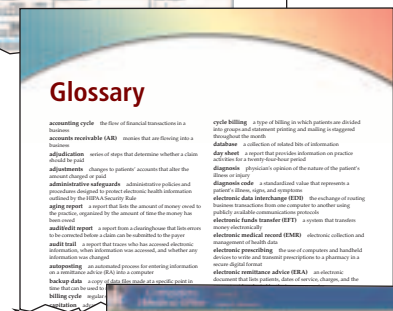
