- Andrews, David L. 2006. The pleasure principle: Sport for the sake of pleasure. *The South Atlantic Quarterly* 105, 2 (Spring; special issue) (Thirteen essays on the passions and pleasures that underlie involvement and experiences in various contemporary sport forms; essays focus on the social and cultural contexts in which individuals give meaning to sports and experience them as a source of joy and excitement).
- Bale, John, and Patricia Vertinsky, eds. 2004. *Sites of sport: Space, place and experience*. New York/London: Routledge (Twelve articles focused on the study of sport places and spaces, including gyms, football stadiums, swimming pools and skating rinks; authors deal with everything from built environments and the body to the tension between global forces and local sport culture).
- Hellison, D., ed. 2000. *Youth development and physical activity: Linking universities and communities*. Champaign, IL: Human Kinetics (Articles written by scholars who have used physical activities as a means of connecting with young people and the neighborhoods where they live; many examples of applied sociology and how an insider perspective can be used to make changes in children's lives through physical activities and sports).
- Gibson, Heather J., ed. 2006. *Sport tourism: Concepts and theories*. London/NY: Routledge (Sport tourism involves travel from one's home community for the purpose of sport competing or enjoyment; the 14 articles in this collection deal with sport tourism from cultural, community, management, and business perspectives).
- Giulianotti, Richard, and David McArdle, eds. 2004. *Sport, Civil Liberties and Human Rights*. London/New York: Routledge (Fourteen articles on the ways that sports contribute to and undermine the human rights of participants, spectators, and workers around the world; focuses on issues of sexual harassment, sexuality, racism, child labor, access to involvement and participation for people with disabilities, and sport as a site of popular protest).
- Murphy, Frank. 2006. *The last protest: Lee Evans in Mexico City*. Kansas City, Mo: Windsprint Press (A writer familiar with U.S. track and field chronicles events leading up Lee Evans participation in the 1968 Olympic Games in Mexico City; this biography is set in the context of the civil rights movement and the call for blacks to boycott the 1968 Olympics).
- Smith, Tommie, and Steele, David. 2007. *Silent gesture: autobiography for Tommie Smith* Philadelphia, PA: Temple University Press (Dr. Tommie Smith tells his life story as it led to and followed his historic gesture on the victory podium during the 1968 Olympic games in Mexico City; his actions and his explanations of them resonate more with people today than at any time over the past 30 years).

Snyder, Brad. 2006. *A well-paid slave: Curt Flood's fight for free agency in professional sports*. NY: Viking (A lawyer and writer tells the story of the professional athlete whose courageous lawsuit against baseball's "reserve clause" was the turning point for transforming player-owner relationships in all professional sports in North America; the biographical material on Curt Flood is compelling and sad).

Zirin, Dave. 2005. *What's my name, fool? Sports and resistance in the United States*. Chicago, IL: Haymarket Books (An independent and award-winning sportswriter describes ten cases in which athletes and others in sports have put themselves on the line by committing themselves to transforming sports in society to be more inclusive, humane, and socially relevant in the world).
