Exercise 11-13


Apply styles and create new styles.


1. Open the file **Agenda - 1**.
2. Use the Quick Style Gallery to apply a style to the document title by following these steps:
 - a. Position the insertion point in the title (the first line).
 - b. Click the More Arrow button  to open the Quick Style Gallery.
 - c. Click **Title**.
3. Use the Styles task pane to apply a style by following these steps:
 - a. Click the **Home** tab, and click the **Styles Dialog Box Launcher** to display the Styles task pane.
 - b. Position the insertion point in the next heading, "Sponsored by."
 - c. Click **Subtitle** in the Styles task pane.
4. Apply the Heading 1 style to the heading "Agenda."
5. Create a new paragraph style for a heading by following these steps:
 - a. Select the heading "Thursday, February 10."
 - b. Click the New Style button , and key **Day** in the **Name** text box.
 - c. Change the font formatting to 14-point bold and small caps.

- d. Change the paragraph formatting to 12 points spacing before and 6 points spacing after. Click **OK** to close the Create New Style from Formatting dialog box.
- e. Apply the Day style to the line beginning “Friday.”
6. Use the Create New Style from Formatting dialog box to create a new style for the agenda text by following these steps:
 - a. Position the insertion point at the beginning of the line that begins “12 Noon.” Click the New Style button  in the task pane.
 - b. Key **Agenda Items** in the **Name** text box.
 - c. Change the font size to 12.
 - d. Click **Format** and choose **Paragraph**.
 - e. Change the left indent to 0.25 inch, and change the spacing after to 3 points. Click **OK**.
 - f. Click **OK** in the Create New Style from Formatting dialog box.
7. Select all the agenda text under the headings “Thursday” and “Friday.” Choose the **Agenda Items** style from the Styles task pane.
8. Apply the Heading 2 style to the line that begins “Grove City College.”
9. Change the document title to small caps and add 72 points of spacing before the paragraph.
10. Save the document as *[your initials]11-13* in your Lesson 11 folder.
11. Submit and close the document.

Exercise 11-14

Create, redefine, modify, and rename styles.


1. Open the file **OH Stores**. Display the Styles task pane.
2. Select the document title, and apply 14-point Times New Roman, bold italic format. Create and apply a paragraph style by right-clicking the selected text, and choosing Styles. Choose **Save Selection as a New Quick Style**, and name the style **Office Heading**.
3. For the text “Campbell’s Confections,” create and apply a paragraph style named **Subhead** with the formatting 12-point Arial, bold italic and with 12 points spacing before and 3 points spacing after paragraphs.
4. Position the insertion point in each line of text that contains a Campbell’s Confections’ store name, and apply the Subhead style (press **F4** to repeat the style).
5. Redefine the Subhead style by following these steps:
 - a. Select the first occurrence of “Campbell’s Confections,” and remove the italic format by clicking the italic button .
 - b. Right-click the **Subhead** style in the task pane. Choose **Update Subhead to Match Selection**.

6. Create a new character style for the word “Fax” by following these steps:
 - a. Position the insertion point at the beginning of the second telephone number for the Akron Office. Click the **New Style** button  in the task pane.
 - b. Key **Fax Num** in the **Name** text box.
 - c. Choose **Character** from the **Style type** drop-down list.
 - d. Click the **Font Color** down arrow to display the color palette, and change the color to dark blue.
 - e. Click **Format**, choose **Font**, and choose **Small caps**. Click **OK**. Click **OK** again.
7. Key the word **Fax:** followed by a space at the beginning of the second telephone number for the Akron office. Repeat for the other five offices.
8. Select the word “Fax” the first time it occurs, and apply the **Fax Num** style from the task pane. Apply the same style to each occurrence of “Fax” by selecting the word and pressing **[F4]**.
9. Rename the Fax Num style by following these steps:
 - a. Right-click the **Fax Num** style in the task pane, and choose **Modify**.
 - b. In the **Name** text box, edit the text to “Fax” and click **OK**.
10. Delete the Office Heading style by following these steps:
 - a. Right-click the **Office Heading** style in the task pane.
 - b. Choose **Delete Office Heading**. Click **Yes**.
11. Apply the Title style to the document title. Modify the style to include small caps. Delete the blank paragraph after the title.
12. Change the top margin to 1.5 inches and the bottom margin to 0.5 inch.
13. Key **Telephone:** followed by a space to the left of each telephone number for all offices. (The telephone number is the first number listed.) Apply the Fax style to the “Telephone:” text.
14. Save the document as *[your initials]11-14* in your Lesson 11 folder.
15. Submit and close the document.

Exercise 11-15

Create styles, use style options, and display and print styles.

1. Open the file **Health Fair**. Display the Styles task pane. Change the date in the memo heading to today’s date. Change the date in the third paragraph below the memo heading to a date two weeks from today’s date. Delete the instruction text.
2. Select the text “Board Room No. 1,” and create and apply a new paragraph style named **Room** with the formatting 12-point Arial, with bold italic and with 3 points spacing after.
3. Apply the new Room style to “Board Room No. 2” and “Board Room No. 3.”




4. Create a new paragraph style named “Session” that is based on the Room style by following these steps:
 - a. Position the insertion point after “Board Room No. 1” and press **Enter**. Key **30-Minute Sessions**. Click the New Style button  on the Styles task pane.
 - b. Key **Session** in the **Name** text box.
 - c. Check that **Style based on** is set to the **Room** style.
 - d. Using the Formatting buttons in the Create New Style from Formatting dialog box, change the font formatting to 11 points and turn off bold and italic.
 - e. Click **OK**.
5. Click at the beginning of the paragraph that starts with the word “Topics.” Create a new paragraph style named **Info** that is based on the Normal style. Use the formatting 11-point Arial, with 3 points of spacing after paragraphs.
6. Assign Session as the following paragraph style for Room, and assign Info as the following paragraph style for Session by following these steps:
 - a. Right-click the **Room** style in the task pane.
 - b. Choose **Modify**.
 - c. Choose **Session** from the **Style for following paragraph** drop-down list.
 - d. Click **OK**. Repeat the procedure to assign Info as the following paragraph style for Session.
7. Position the insertion point at the end of the heading “Board Room No. 2,” press **Enter** to apply the Session style, and key **45-Minute Sessions**.
8. Press **Enter** to apply the Info style and key **Topics**.
9. At the end of “Board Room No. 3,” press **Enter**, and key the following two lines of text:

30-Minute Sessions
Topics:
10. Select the text from “CPR” to “First Aid,” and format the text as a bulleted list using a small square bullet (▪). Right-click the selected text, and choose **Styles** from the shortcut menu. Click **Save Selection as a New Quick Style**. Name the style **Content**, and click **OK**.
11. Select the two lines of text that follow “Topics for Board Room No. 2,” and apply the Content style. Repeat the style for the three lines of text under “Topics for Board Room No. 3.”
12. Modify the Normal style to be Arial, with single spacing.
13. Display the style area for the document by following these steps:
 - a. Open the **Word Options** dialog box, and click **Advanced**. Scroll to the **Display** group.
 - b. Set the **Style area width** to 0.5 inch and click **OK**. Switch to Draft view.
14. Format the memo with the correct spacing at the top of the page, and remember to include your reference initials at the end of the document. Change the bottom margin to 0.5 inch.

15. Restore the style area width to zero. Switch to Print Layout view.
16. Print the document style sheet by following these steps:
 - a. Open the Print tab.
 - b. Choose **Styles** from the **Print All Pages** drop-down list, and click **OK**.
17. Spell-check the document, and save it as *[your initials]11-15* in your Lesson 11 folder.
18. Submit and close the document.

Exercise 11-16

Apply and customize document themes.

1. Open the file **Health Fair - 2**. Display the Styles task pane.
2. Change the document theme by following these steps:
 - a. Click the **Page Layout** tab, and click the Themes button .
 - b. Click the **Median** design from the Themes Gallery.
3. Change the theme font by following these steps:
 - a. Click the Theme Fonts button .
 - b. Click **Create New Theme Fonts**.
 - c. Change the heading font to **Tahoma**, and change the body font to **Tahoma**.
 - d. Key **Custom Font** in the **Name** text box. Click **Save**.
4. Modify the Normal style by changing the font size to 12.
5. Apply the style Heading 1 to the first line of the document. Apply the Heading 2 style to the text that begins “Saturday.”
6. Apply the Heading 3 style to the headings “Employee’s Full Name,” “Store Location,” and “Preferred Sessions.” Modify the Heading 3 style to 24 points spacing before and 3 points spacing after.
7. Click the Page Layout tab if necessary, and click the Theme Colors button . Click **Create New Theme Colors**. Change the **Accent 1** color to the last color in the fifth column, Ice Blue, Accent 1, Darker 50%. Key **Custom Color** in the **Name** text box, and click **Save**.
8. Format the document with a 1.5-inch top margin.
9. Spell-check the document.
10. Save the document as *[your initials]11-16* in your Lesson 11 folder.
11. Submit and close the document.

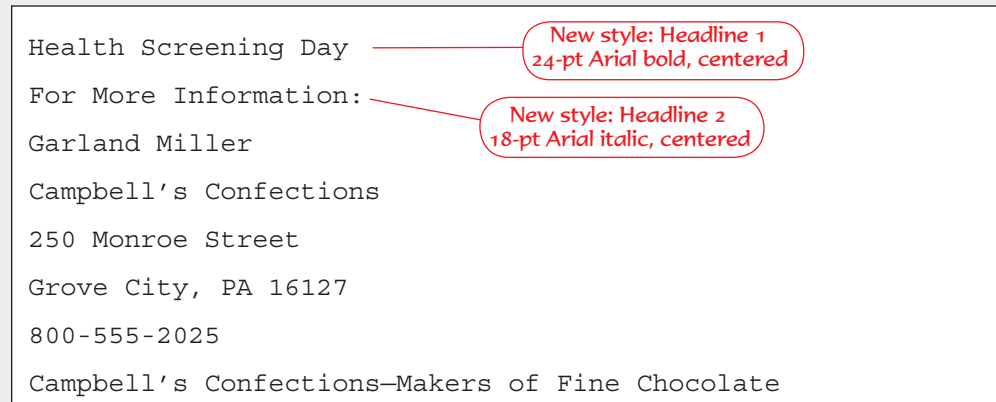

Exercise 11-17

Create, apply, and modify styles; print styles.

1. Start a new document. Key the text shown in Figure 11-15. Create the styles as indicated for the first two lines.

2. Apply the Headline 2 style to the last line of text. Modify the style to include 18 points of paragraph spacing before and after.
3. Create a style called **Body 1** (based on the Normal style) for the remainder of the text; the style should be 12-point Arial, centered, with 1.5-line spacing.
4. Center the document vertically on the page.
5. Click the Change Styles button  on the Home tab, and change the style set to Traditional.
6. Add a page border to the document.
7. Spell-check the document.
8. Save the document as *[your initials]11-17* in your Lesson 11 folder.
9. Submit the document and the style sheet, and close the document.

Exercise 11-18

Create, modify, and rename styles; print styles.

1. Open the file **Screening**.
2. Create a character style named **Memo Heading** using Arial Black, 12 points.

3. Select “Memo To:” and apply the Memo Heading style. Repeat the style formatting for “From:,” “Date:,” and “Subject:.”
4. Select the four lines in the memo heading, and adjust the tab setting to 1.25 inches.
5. Modify the Normal style to include 12-point Times New Roman and 12 points spacing after.
6. Select the text beginning “Height and weight” through “Asthma screening,” and format the text using a picture bullet.
7. Rename the style Memo Heading with the name **Memo Head**.
8. Position the insertion point in the subject line of the memo heading, and change the spacing after to 24 points. Add a bottom border to the subject line.
9. Change the top margin to 2 inches and the bottom margin to 0.5 inch.
10. Add your reference initials to the document.
11. Save the document as *[your initials]*11-18 in your Lesson 11 folder.
12. Submit and close the document.

Modify styles, use style options, and print styles.

1. Open the file **Property - 2**.

10. Key the following closing paragraph.

11. Key the closing lines of the letter.
12. Modify the font size of the Normal style to 12 points.
13. Spell-check the document.
14. Save the document as *[your initials]11-19* in your Lesson 11 folder.
15. Print the style sheet and the document, and close the document.

Exercise 11-20 ♦ Challenge Yourself

Create, apply, and modify styles; apply themes.

1. Open the file **Ordering**. Display the Styles task pane.
2. Apply the Opulent theme to the document.
3. Apply the Title style to the first line of the document.
4. Position the insertion point in the “Online” paragraph. Create a style called **Side Heading** using 14-point bold and small caps formatting.
5. Apply the Side Heading style to each of the document side headings. (There are seven side headings.)
6. Position the insertion point in the paragraph that begins “Note,” and create a new style named **Special Note** using 11 points and 0.25-inch left indent.
7. Apply the Special Note style to each “Note” paragraph and the paragraph that follows “Note.”

8. Modify the style of the Normal font to 11 points.
9. Modify the Title style to small caps.
10. Create a left-aligned header for page 2 to include the following text. Place two blank paragraphs after the second line of the header.

11. Add a bottom border to the page number paragraph in the header.
12. Add your reference initials to the bottom of the document.

Exercise 11-21

Exercise 11-23

Create a document that includes your five favorite songs. Each song should appear as a three-line description—song title, songwriter, and performer—with each line using a different style. The songwriter and performer styles should be based on the song title style. Specify the songwriter style as the style following the title style, and the performer style as the style following the songwriter style. Create the styles first; then key the text. Modify the styles as desired. Save the document as *[your initials]11-23*. Submit the document and the styles.
